





Why bother?

“All those who are involved in work to improve social outcomes want to know that the programmes and interventions put in place achieve results and improve the lives of people and their communities.”

(Stern, 2015)

What is policy evaluation?

“Assessing the strengths and weaknesses of programs, policies, personnel, products and organisations”

(American Evaluation Association)

“The process of determining the merit, worth, or value of something or the product of that process.”

(Scriven, 1991)


“The use of social science methods to systematically investigate the effectiveness of social intervention programs.”

(Rossi et al, 2004)

Purpose of evaluation

FORMATIVE ... to 'improve'	SUMMATIVE ... to 'prove'
<p>“designed, done, and intended to support the process of improvement, and normally commissioned or done by, and delivered to, someone who can make improvements”</p>	<p>“done for, or by, any observers or decision makers (by contrast with developers) who need evaluative conclusions for any reasons besides development” <i>(Scriven, 1991)</i></p>

Theory of Change



Types of evaluation

Type	Key question
Monitoring	Is the implementation progressing as planned?
Performance management	Are milestones being achieved?
Process evaluation	How is the policy implemented? Do we observe expected behaviours? Why? Why not?
Outcome evaluation	Has the policy achieved its intended goals?
Impact evaluation	Did the policy produced the intended effects compared to what would have happened anyway?
Cost benefit analysis or Value-for-money	Are the policy benefits worth its costs?
Understanding key mechanisms	Why did it work or not work?



Formulating the evaluation question(s)




Alice asked the Cheshire Cat, who was sitting in a tree, “What road do I take?”

The cat asked, “Where do you want to go?”
“I don’t know,” Alice answered.

“Then,” said the cat, “it really doesn’t matter, does it?”


Double trouble – what are we evaluating?

A. What is the causal mechanism for SIBs?



Amongst existing SIB evaluations there is ambiguity in the SIB causal mechanism

B. What is the impact of SIBs?



Where evaluations investigate impacts these typically assess the intervention (A) rather than the 'SIB effect' (B)

Practical considerations



I called you all here because
I need you to stop helping people.
It's really messing up my impact assessment.

Some key considerations

- Will the evaluation be externally commissioned or conducted in-house?
- Who will be responsible for specification development, tendering, project management and quality assurance?
- When does any primary data collection need to take place?
- When will the evaluation start and end?
- What budget is to be used for the evaluation and is this compatible with the evaluation requirements?
- Has sufficient allowance been built in or are there other sources of funding to support the evaluation?

Data requirements and availability

- What data are required?
- What is already being collected / available?
- What additional data need to be collected?
- If the evaluation is assessing impact, at what point in time should the impact be measured?
- Who will be responsible for data collection and what processes need to be set up?
- What data transfer and data security considerations are there

What to include in an ITT (I)

✓ Background

A clear and concise description of activities being evaluated, incl. information on: your organisation; policy, programme, or intervention activities; intended outcomes; timescales; partner organisations; etc.

Data available for evaluation including management information, administrative data, and primary data collection; timing of data collection

✓ Aims & objectives

The articulation of your specific evaluations questions. If these questions are unique to specific phases of the project, it is appropriate to state these across phases with differing aims and objectives for each phase.

✓ Methodology

Statement of any preferred methodologies (e.g. qualitative, quantitative, mixed methods) or evaluation activities (e.g. reflective learning events, practitioner workshops) or requirements for evaluators engaging with vulnerable populations

What to include in an ITT (II)

✓ Dissemination

Preferred reporting methods for findings (this is usually a written report, but other, more approachable, easier to digest and learn-from formats include: plain English executive summaries, case studies, conference presentations, workshops and seminars, videos, blogs, articles).

✓ Deadlines

✓ Deliverables

Explicit statement of what is required over the course of the project, incl.: project planning and scoping meetings; project initiation document; attendance and participation at steering group meetings; research tools; evaluation framework; reporting; presentation of results and recommendations

✓ Budget



There are pros and cons to including a budget in an ITT. If you provide a budget, evaluators will base their proposal on that figure, meaning you may curtail the opportunity to procure cheaper. However, providing a budget figure to evaluators gives them an idea of the required depth of research.




